

Cyclone Fani and Subsequent Measures

The tropical cyclone Fani, said to be the most severe storm to hit the Indian subcontinent in two decades, made a landfall on the coast of Odisha. The cyclone unleashed heavy rains and windstorm that left people devastated with lack of food, shelter, scarcity of drinking water, loss of crops & agriculture, overpopulated rescue shelters, demolished the green covers that spanned across the three affected districts of Puri, Khurda and Cuttack. On the operational front, Sambandh has very strategically not expanded its branch network here in the coastal belt of Odisha. However, operations under two of its branches - Bhubaneswar (in Khurda) and Chandbali (in Bhadrak) have faced the adverse effect of the cyclone, particularly the areas under Bhubaneswar branch. There are about 719 clients under Bhubaneswar branch – out of them about 225 clients saw their livelihoods being severely affected by the cyclone. During the extreme situation faced by the clients, the branch staff have been vigilant and visited client places to understand the extent of the impact and enquire about any kind of support required to bring them back to their normal life. While understanding the grievous nature of the cyclone which has poorly affected the livelihoods of the clients - the branch staff were encouraged and supported by the Corporate Office in providing a helping hand to the clients. Out of the 225 clients, about 200 clients have been provided with necessary relief materials (tarpaulin sheet, biscuit packets, flaked rice, sugar, candle and match box). The response from the state association OSAFII on how to deal the after-effects of cyclone in a credible way has been commendable; simultaneously the quick review meetings, sharing of regular updates, helpful suggestions (Do's & Don'ts – after the advent of such natural disasters) by the SRO and industry association - MFIN were also appreciable. While joining other OSAFII members, Sambandh contributed to Chief Minister's Relief Fund, Odisha, for relief and rehabilitation of the cyclone affected families.



The Social Goals and SPM activities are on track and gained momentum, resulting in 80% score as on 31st March 2019 with respect to 66% in December 2018.
